Based on the analysis of the pestsrisks regarding importing the Indian wheat and after sending a technical committee to the state of Indian to review the systems of inspecting grains and the Phytosanitary measures followed there and the report of the committed submitted to us, we decided the following:

Approving the Indian origin for importing wheat and thus India will be on the list of approved origins for importing wheat

It is a precondition to get a prior importation permits from CAPQ indicating the following technical conditions

## Sub: Registration of Indian wheat exporters for supply to GASC

The Embassy is in receipt of a letter dated 28 March 2022 from the General Authority of Supplies and Commodities (GASC - the Egyptian Public Procurement Agency that procures essential commodities like wheat, sugar, etc. from overseas), requesting interested Indian companies willing to supply wheat to Leypt through GASC, to register with the Agency through any local agent or representatives. The Indian companies would need to complete the necessary procedures, to be eligible to enter into a supply contract with GASC.

- In this regard, the Egyptian side has conveyed that they desire to procure a significant amount of wheat from Indian suppliers, once India is added to the list of accredited countries which can export wheat to Egypt.
- 1 am attaching the list of documents (Annexure A) that the Indian exporter have to submit, through a local agent representative office for completing the registration formalities with GASC, in order to participate in tenders for supplying wheat to the Agency.
- I am also attaching list of main importers of wheat in Egypt, a database sourced from the leading Chambers of Commerce and other Business Associations here in Egypt. (Please note that the list is purely indicative and not exhaustice Indian exporters are advised to hollow due diligence while dealing with the
